## **Tietto appoints Exploration Manager to lead Abujar exploration**

### **Highlights:**

- **Newcrest Mining West Africa Senior Geologist Dr. Mathieu Ageneau has agreed to join Tietto as Exploration Manager**
- **Dr Ageneau will lead Tietto's extensive 2018-19 work program as it focuses on growing the Abujar gold resource**

West African gold developer and explorer Tietto Minerals Limited (ASX: TIE) (**Tietto**) is pleased to announce the appointment of senior exploration geologist Dr. Mathieu Ageneau as its Exploration Manager as the Company accelerates exploration of its Abujar Gold Project in Côte d'Ivoire.

Dr Ageneau is currently Newcrest Mining Limited's West Africa Senior Geologist, leading the team which discovered the Antenna gold deposit at Seguela in Côte d'Ivoire.

He also worked in West Africa with SRK Exploration Services and has previous exploration experience in Australia with Gold Fields Australasia, as well as Serbia (First Quantum Minerals), Peru (Pan American Silver) and Papua New Guinea (Lihir Gold).

Tietto Managing Director Dr Caigen Wang said the Company was pleased to have attracted a high-calibre candidate to the role.

*"Mathieu has an excellent track record in successful West African gold exploration, and more specifically in Côte d'Ivoire, and helped Newcrest discover the 430,000oz Antenna resource. We are confident he can lead Tietto in rapidly expanding our resources at Abujar as we continue to report high grade results over thick intercepts,"* he said.

Tietto has planned an extensive work program for 2018-19 to explore its Abujar project, where it is focused on the Abujar Middle tenement as well as preliminary work at the Abujar North and South tenements. The Abujar Project has a JORC Inferred Resource 10.4Mt at 2.1g/t Au for 703,600oz and Tietto is aiming to upgrade this in late 2018 following completion of 15,000 metres of RC and diamond drilling in Q4 2018, with a further upgrade expected in 2019.

Dr Ageneau will commence work with Tietto in early 2019.
